VACANCY FOR THE POST OF ELECTRICAL POWER TECHNICIAN

Multi Carrier (Mauritius) Ltd, a State-Owned Enterprise, having exclusive rights for Terrestrial Radio and Television broadcasting in the Republic of Mauritius, is inviting applications from suitably qualified candidates who wish to be considered for appointment as **Electrical Power Technician**.

II. AGE LIMIT

Candidates should not have reached their 35th birthday by the closing date for the submission of applications.

III. QUALIFICATIONS AND EXPERIENCE

A. Candidates should possess:

1. The Certificate of Primary Education.
2. The National Trade Certificate Level 3 in Electrical Installation works issued jointly by the Mauritius Examinations Syndicate and the Mauritius Institute of Training and Development or an equivalent qualification acceptable to the Board.
3. At least one year experience in single phase and 3-phase electrical industrial wiring and systems.
4. Should be in good physical condition and have a good eyesight.

NOTE 1: Candidates who possess qualifications at 1, 2 and 4 above and reckon at least one year experience in single phase but have no experience in 3-phase electrical industrial wiring and systems will also be considered. They will be appointed in a temporary capacity, in the first instance, and will be required to follow a six-month theoretical and practical training course in 3-phase electrical industrial wiring and systems, as approved and arranged by MCML. On successful completion of the training, they will be considered for employment in a permanent and pensionable capacity.

IV. DESIRABLE SKILLS AND KNOWLEDGE

Candidates should possess the:

- Ability to work at heights;
- Ability to communicate efficiently and fluently;
- Ability to use all equipment, tools and materials efficiently as per requirements of the job and in accordance with Health and Safety guidelines;
- Ability to diagnose and solve problems on electrical systems promptly.

V. DUTIES AND RESPONSIBILITIES

- (i) To perform temporary and permanent wiring of electrical networks inside and outside the Company's premises.
- (ii) To assist in the proper repairs and maintenance of electrical installations on all Company's premises including mast lights.
- (iii) To deal with the 3-phases of electrical supply, high power transmitters, high KVA generators installed in stations in the territory of Mauritius, UPS, industrial/domestic Air conditioners, DC supply, batteries, electronic cards, etc.
- (iv) To prepare estimates for electrical works including maintenance works.
- (v) To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Electrical Power Technician.

NOTE 2: The Electrical Power Technician shall be required to work in accordance with the exigencies of the company, on shift, outside normal working hours including Sundays, Public Holidays and Cyclonic days and on and off the Company's premises in Mauritius, Rodrigues or any of the outer islands of the Republic of Mauritius.

VI. SALARY

The permanent and pensionable post carries salary in the scale Rs 16525 x 260 – 17825 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 - 26050 x 675 – 27400 x 825 – 33175 a month.
